Know All Men by These Presents:

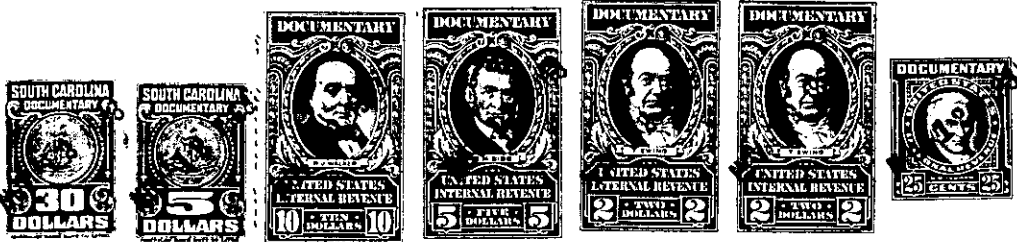
That I, J. Frank Williams

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hestley D. Stepp, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 42 on a plat of Indian Hills, recorded in the RMC Office for Greenville County in Plat Book QQ, Page 11 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Hunts Bridge Road at the joint front corner of lots 42 & 43 and running thence with the common line of said lots N. 82-35 E. 180 feet to an iron pin; thence S. 7-25 E. 100 feet to an iron pin, the joint rear corner of Lots 41 & 42; thence with the common line of said lots S. 82-35 W. 180 feet to an iron pin on the easterly side of Hunts Bridge Road; thence with said road N. 7-25 W. 100 feet to the point of beginning and being identically the same property conveyed to grantor herein by deed of J. O. Heatherly on June 5, 1962.
