Two Thousand Five Hundred and no/100----- Dollars, and assumption of mortgage as set forth herein below; the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Mattie F. Gray, her heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known and designated as Lot No. 8 of a subdivision of the property of Greenville Land Co., Inc., as shown on a plat thereof prepared by Piedmont Engineering Service recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 89, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Clemson Avenue, the joint front corner of Lots Nos. 8 and 9 and running thence along the joint line of said lots, S. 56-40 E. 143 feet to an iron pin on the line of property now or formerly of O. I. Cox; thence along the line of that property, S. 33-20 W. 70 feet to an iron pin on the northeastern side of a strip reserved for a street; thence along the northeastern side of said reserved strip, N. 56-40 W. 118 feet to an iron pin; thence following the curvature of said reserved strip as it intersects with Clemson Avenue, the chord being N. 11-40 W. 35.4 feet to an iron pin on the southeastern side of Clemson Avenue; thence along the southeastern side of Clemson Avenue, N. 33-20 E. 45 feet to the beginning corner.
