in the State aforesaid,

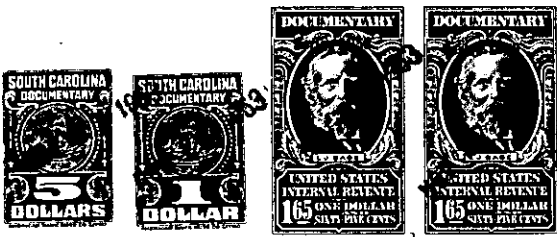
in consideration of the sum of Twenty Seven Hundred Ninety Five and no/100 (\$2795.00) DOLLARS,
