That I, J. A. PITTMAN,

in consideration of the sum of One Thousand and 00/100 (\$1,000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. H. MORGAN, his heirs and assigns, forever:

ALL that lot of land situate on the South side of Pittman Circle, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 13 on plat of property of J. A. and Maggie B. Pittman, made by R. K. Campbell, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book RR, Page 143, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Pittman Circle at joint front corner of Lots 12 and 13, and runs thence with the line of Lot 12, S. 33-50 E., 139.2 feet to an iron pin; thence N. 56-10 E., 132 feet to an iron pin; thence with the line of Lot 14, N. 33-50 W., 139.2 feet to an iron pin on the Southeast side of Pittman Circle; thence along Pittman Circle, S. 56-10 W., 132 feet to the beginning corner.

This is a portion of that property conveyed to Mrs. Lease Pittman by deed of Nellie Grace Brown, dated October 19, 1929, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 134, at Page 342. Subsequently, Mrs. Lease Pittman died testate and by her Will which is on file in the office of the Probate Court for Greenville County, S. C., in Apartment 625, File 34, she devised the above property to the grantor, J. A. Pittman.

This property is conveyed subject to the restrictions recorded in Deed Book 612, Page 195, R. M. C. Office for Greenville County, S. C.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

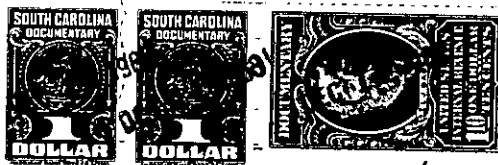
