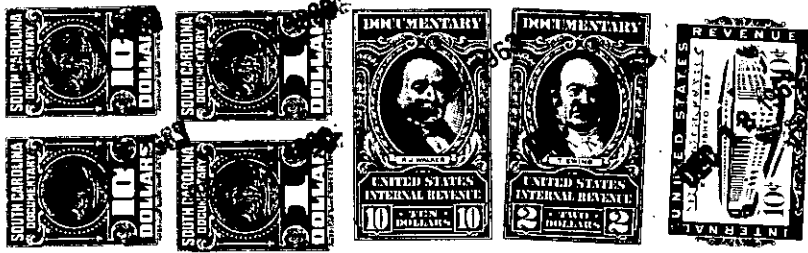
in the State aforesaid, in consideration of the sum of Ten Thousand Nine Hundred and no/100 (\$10,900.00) - DOLLARS,

Raymond W. O'Reilly, his heirs and assigns, forever:

All that piece, parcel or lot of land, with buildings and improvements thereon, situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 75 on a plat of the Revision of the Extension of Shamrock Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Page 133 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of County Cork Drive at the joint front corner of Lots 75 & 76 and running thence with the common line of said lots N. 52-40 W. 174.1 feet to an iron pin; thence N. 34-23 E. 85.1 feet to an iron pin, the joint rear corner of Lots 74 & 75; thence with the common line of said lots S. 52-40 E. 178.4 feet to an iron pin on the northwesterly side of County Cork Drive; thence with said drive S. 37-20 W. 85 feet to the point of beginning.
