Willis, Engineers, dated March 1960 and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 33, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Casa-Loma Street, joint front corners of Lots Nos. 5 and 6 and running thence along the line of said lots, S. 0-30 W. 173.3 feet to iron pin; thence running with rear line of Lot 6, S. 82-43 W. 80.7 feet to iron pin rear corner of Lot 7; thence running with line of said lot, N. 0-30 E. 180 feet more or less to iron pin on Casa-Loma Street; thence running with Casa-Loma Street, S. 87-35 W. 80 feet to iron pin point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty (30) feet, to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.
