All that certain parcel or lot of land on the southeast side of Meridian Avenue between Greenville and Taylors, in Chick Springs Township of Greenville County, South Carolina, being Lot No. 61 of SUPER HOME SITES according to survey and plat by Sam M. Hunter, Registered Surveyor, recorded in Plat Book P, page 53, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:
