the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto BRUCE H. MOSELEY, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 23 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Larkspur Drive at the joint front corner of Lots 22 and 23 and running thence with the Southwestern side of Larkspur Drive S 38-21 E 81 feet to a point; thence continuing with the Southwestern side of Larkspur Drive S 52-30 E 50 feet to a point; thence following the curvature of the Western intersection of Larkspur Drive with Avon Street (the chord of which is S 18-47 E 30 feet) to a point; thence with the Northwestern side of Avon Street S 22-31 W 143.5 feet to a point at the joint front corner of Lots 23 and 24; thence N 67-29 W 164.7 feet to a point at the joint rear corner of Lots 23 and 24; thence N 29-13 E 220.2 feet to the point of BEGINNING.
