Dan Edwards and Hazel H. Edwards, their heirs and assigns forever:

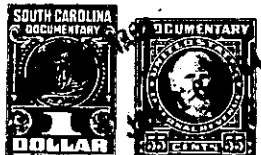

M. C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on East Monticello Road, joint front corners of Lots 31 and 32 and running thence along the lines of said lots, N. 71-00 W. 227.5 feet to iron pin rear corners of Lots 40 and 39; thence running with rear line of Lot 39, N. 14-45 E. 79 feet to iron pin rear line of Lot 35; thence running with lines of Lots 35, 34 and 33, S. 70-20 E. 234.6 feet to iron pin on East Monticello Road; thence running with said Road, S. 19-00 W. 80 feet to iron pin point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
