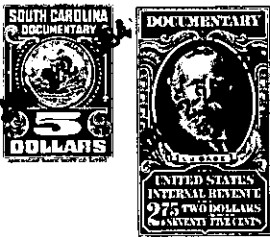

V. CHANDLER & CO., INC.

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 68 on plat of Drexel Terrace dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the northwesterly side of Dexter Drive at the joint front corner of Lots 69 and 68 and running thence along the northwesterly side of Dexter Drive, S. 7-53 W. 100.0 feet to a point, joint front corner of Lots 68 and 67; thence turning and running along the common boundary of said lots, N. 82-07 W. 162.5 feet to a point in line of Lot 79, joint rear corner of Lots 68 and 67; thence turning and running along portions of the rear line of Lots 79 and 78, N. 6-23 E. 100.0 feet to a point in the rear line of Lot 78, joint rear corner of Lots 68 and 69; thence turning and running along the common boundary of Lots 68 and 69, S. 82-07 E. 165.0 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 355 and to building set back line as shown on said plat.

This is a portion of the property conveyed to the grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 155.
