

TRACT 47

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning on the county road between the properties now or formerly of Elise Louise Kohn and R. C. Simpson 253.35 feet southeast from the intersection of said county road and east right-of-way of U. S. Highway No. 29; thence along the arc of a 5 degree curve to the right 142.84 feet; thence along the arc of 4 degree curve to the right 436.36 feet to a point on the property line now or formerly of R. C. Simpson which is S 26°35' W 15 feet from the northeast corner of said tract; containing 0.923 acre, more or less.

TRACT 48

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning at a point on the east right-of-way of U. S. Highway No. 29, which is N 16°20' E 95.7 feet from the southwest corner of property now or formerly of Elise Louise Kohn; thence along the arc of a 5 degree curve to the right 299.5 feet to a point in the center of the county road, a common line between the property now or formerly of E. Louise Kohn and R. C. Simpson, said point being 241.3 feet southwesterly from the east right-of-way of U. S. Highway No. 29; containing 0.48 acre, more or less.

TRACT 49

Beginning at a concrete monument at the southeast corner of the tract on the Donaldson Air Force Base reservation boundary line, said point being approximately 200 feet east of the intersection of Missouri Street and Nebraska Street at Gate No. 2; thence running N 62°54' W along the reservation boundary line 218.04 feet to a concrete monument; thence N 10°10' W along the reservation boundary line and the east right-of-way line of U. S. Highway No. 25 a distance of 462.36 feet to a concrete monument; thence N 10°02' W along the reservation boundary line and east right-of-way line of U. S. Highway No. 25 a distance of 936.70 feet to a concrete monument; thence S 53°00' E along lands now or formerly of the United States Government 1150.5 feet to a concrete monument; thence S 31°30' W along lands now or formerly of the United States Government a distance of 920.72 feet to the point of beginning and containing 14.68 acres, more or less.

TRACT 70

Beginning at a point in the center of a public highway, said point being the most southern corner of the Antioch Church and cemetery property and the most easterly corner of the following described property; thence S 49°07' W 350.0 feet and S 51°42'30" W 250 feet along the center line of said road; thence leaving said road through the lands now or formerly of Maude P. Willimon, N 40°50' W 592.83 feet and N 49°07' E 760.18 feet to the most westerly corner of Antioch Church and cemetery property; thence along said Antioch Church and cemetery property, S 26°00' E 624.93 feet to the point of beginning and containing 9.4 acres, more or less.
