

TRACT 54

BEGINNING at station 36+30 at a survey for a 20 ft. right-of-way for a power line across the lands now or formerly of Willimon - Fendley - Cox - Payne and Ayers, said station 36+30 being a point in the line now or formerly of Cox and Payne; thence with line of survey S 22°20' W 95 feet to a point; thence S 43°45' W, 495 feet to a point; thence N 80°54' W, 740 feet to station 49+60 a point on the line now or formerly of Payne and Ayers, and containing 0.07 of an acre, more or less.

TRACT 55
