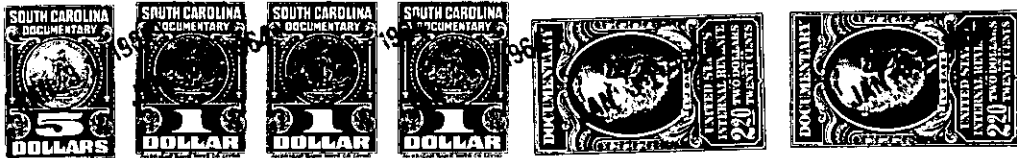

unto O. Tommy Gibbs and Ray T. Dempsey, their heirs and assigns forever:

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the western side of White Horse Road and on the southern side of Lewis Street and being known and designated as a portion of Lots Nos. 60 and 61 of Earle Subdivision property of Looper and Yown as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "F", at Page 77 and having, according to said plat, the following metes and bounds, to-wit:

PORTION OF LOT NO. 60: BEGINNING at an iron pin on the western side of White Horse Road at joint corner of Lots Nos. 60 and 61 and running thence along the joint line of said lots S. 79-45 W. 262.6 feet to an iron pin; thence S. 10-15 E. 50 feet to a stake; thence N. 79-45 E. 243.2 feet, more or less, to a stake on the western side of White Horse Road; thence along the western side of said Road N. 11 E. 53.85 feet to an iron pin, the point of beginning, and being the same property conveyed to the grantor by deed recorded in Deed Book 602, at Page 296.

PORTION OF LOT NO. 61: BEGINNING at a stake on the south side of Lewis Street 230.2 feet in a westerly direction from White Horse Road and running thence along said Lewis Street S. 79-45 W. 110 feet to an iron pin at the corner of Lot No. 59; thence along the line of Lot No. 59 S. 10-15 E. 200 feet to an iron pin; thence along the joint line of Lots Nos. 60 and 61 N. 79-45 E. 110 feet to a point; thence N. 10-15 W. 200 feet to the point of beginning, and being the same property conveyed to the grantor by deed recorded in Deed Book 625, at Page 64.
