All that lot of land in the county of Greenville, state of South Carolina, on the west side of Phillips Trail, designated as "Batson" on plat made by C. C. Jones, Engineer, January 22, 1964 recorded in the RMC Office for Greenville County, S. C., in plat book FFF page 21, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Phillips Trail, corner of property this day conveyed to the grantee and designated on said plat as "Mull Prop"; thence with the line of said property S. 87-35 W. 87 feet to an iron pin; thence S. 37-15 W. 112.7 feet to an iron pin; thence with a new line through property of the grantor N. 20-55 W. 92 feet to an iron pin; thence continuing N. 53-42 E. 130 feet to an iron pin; thence continuing N. 58-42 E. 100 feet to an iron pin on the west side of Phillips Trail; thence with the west side of said Road S. 1-02 W. 121.5 feet to the beginning corner.
