All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the western side of Carter Drive (formerly Canter Drive) and being known and designated as Lot No. 23 of Laurel Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "KK", at Page 33 and having, according to said plat, the following metes and bounds, to-wit:
