the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto RICHARD L. DEESE

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 86 on plat of Drexel Terrace dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the westerly side of Kimberly Lane, joint front corner of Lots 86 and 87 and running thence along said westerly side of Kimberly Lane, S. 6-37 W. 95.0 feet to the joint front corner of Lots 86 and 85; thence turning and running along the common boundary of said lots, N. 84-44 W. 199.2 feet to a point in the rear boundary of Lot 94, joint rear corner of Lots 85 and 86; thence turning and running along a portion of the rear boundary of Lot 94, N. 1-18 E. 52.8 feet to a point; thence N. 5-43 E. 30.8 feet to a point, joint rear corner of Lots 86 and 87; thence turning and running along the common boundary of said lots, S. 88-00 E. 205.0 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the RMC for Greenville County in Deed Book 671 at page 355 and to building set back line as shown on said plat.

This is a portion of the property conveyed to the grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 155.
