unto WILLIAM C. HUFFMAN and ANGELEE L. HUFFMAN, their heirs and assigns:

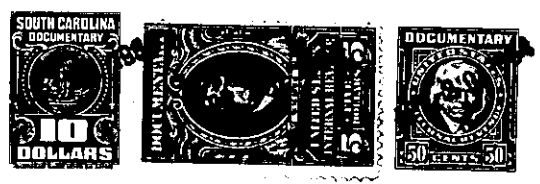
ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate,
lying and being near the City of Greenville, in the County of Greenville, State of South
Carolina, being known and designated as Lot 203, Section A on Plat of Woodfield, plat of
which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book
"W", at Page 75, and having the following metes and bounds to-wit:

BEGINNING at an iron pin on the Easterly side of Foxhall Road, joint front corner Lots
