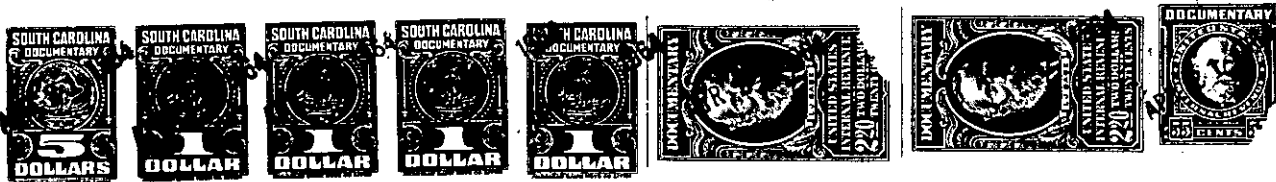
ALL that piece, parcel or lot of land in Greenville County, South Carolina on the southern side of Lowndes Hill Road in the City of Greenville, being the eastern one-half of Lot 93 as shown on plat No. 3 of Overbrook Land Company made by R. E. Dalton, January, 1924 and recorded in Plat Book F, at page 218, and sometimes referred to as Lot #93 B and described as follows:

BEGINNING at a stake on the southern side of Lowndes Hill Road 755.3 feet east from Overbrook Road in the center of Lot 93 and running thence S. 13-16 W. 95 feet to stake; thence S. 75-54 E. 62.5 feet to stake at the corner of Lot 94; thence with the line of said lot N. 13-16 E. 96.1 feet to stake on Lowndes Hill Road; thence with the southern side of Lowndes Hill Road N. 76-44 W. 62.5 feet to the beginning corner.

This conveyance is made subject to a conveyance of a strip of 17 feet conveyed by deed of Woodville Investment Company in Deed Book 72 at page 248.

This property being the same property heretofore conveyed to the grantor by the grantee.

As further part of the consideration the grantee re-assumes and agrees to pay the balance due upon a mortgage executed by him to C. Douglas Wilson & Co. recorded in Mortgage Book 392 at page 349 in the original amount of \$6900, upon which there is due a present balance of \$1,709.40.
