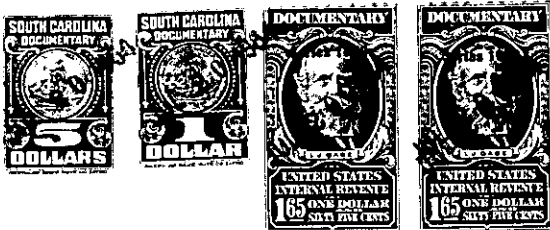
in consideration of Twenty Seven Hundred and no/100-----(\$2700.00)-----Dollars,
