All that certain piece, parcel or lot of land, lying and being on the southerly side of Patti Drive, near the City of Greenville, S. C., and being designated as Lot 14 on the Plat of Staunton Heights as recorded in the RMC Office in Plat Book RR, page 167, and having according to said plat the following metes and bounds, to-wit;
