of Greenville, on the western side of By-Pass S. C. Highway No. 29, near the City of
Greenville, being shown as Lot No. 48 on plat of the Estate of Tully P. Babb, recorded
in Plat Book "GG" at pages 158 and 159, and described as follows: BEGINNING at a
stake on the western side of By-Pass S. C. Highway No. 29 at corner of property of
City of Greenville, and running thence with the line of said property N. 83-04 W.
360.2 feet to a stake at corner of Lot 49; thence with the line of said lot S. 6-50 E.
282.3 feet to a stake at corner of Lot 47; thence with the line of said lot N. 83-10 E.
