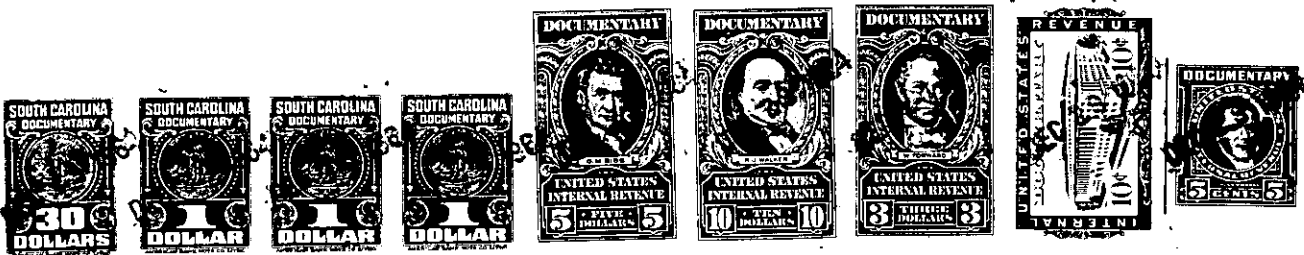
KNOW ALL MEN BY THESE PRESENTS, that Mauldin Construction Company

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Paul Fitzhugh Wyatt, II, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot 27 on a plat of Edwards Forest dated January 1955 by Madison H.
