Granger which is South  $33^{\circ} 5'$  West, approximately 42 feet from the most northern corner of said tract; thence South  $76^{\circ} 20'$  East 58 feet to a point on the property line now or formerly common to S. D. Granger and O. K. Granger South  $37^{\circ} 25'$  East, approximately 64 feet from the most northern corner of said tract; containing 0.08 of an acre, more or less.

PARCEL NO. 12 (TRACT NO. 38)

A 60 foot strip of land extending 30 feet on each side of and parallel to the center line described as follows: Beginning at a point on the property line now or formerly common to O. K. Granger and S. D. Granger South  $37^{\circ} 25'$  West, approximately 64 feet from the southwest corner of property now or formerly of O. K. Granger; thence South  $77^{\circ} 10'$  East 160 feet to a point on the property line now or formerly common to O. K. Granger and Mrs. Florence Batson which is South  $35^{\circ} 5'$  West, approximately 111 feet from the northeast corner now or formerly of O. K. Granger tract; containing 0.22 of an acre, more or less.

PARCEL NO. 13 (TRACT NO. 37)

A 60 foot strip of land extending 30 feet on each side of and parallel to the center line described as follows: Beginning at a point on the western property line now or formerly of Florence Batson which is a common line with property now or formerly of O. K. Granger South  $33^{\circ} 5'$  West, approximately 111 feet from the southeast corner now or formerly of the O. K. Granger tract; thence South  $77^{\circ} 10'$  East 308.5 feet to a point on the property line now or formerly common to Florence Batson and Mrs. Kathleen B. Granger South  $4^{\circ} 30'$  West 700 feet from the northeast corner now or formerly of the Florence Batson tract on Whitehorse Road; containing 0.42 of an acre, more or less.

PARCEL NO. 14 (TRACT NO. 36)

A 60 foot strip of land extended 30 feet on each side of and parallel to the center line described as follows: Beginning at a point on the western property line now or formerly of Mrs. Kathleen B. Garrison South  $4^{\circ} 30'$  West 700 feet from the northwest corner of said tract; thence South  $77^{\circ} 10'$  East 328.3 feet to the eastern property line of aforementioned tract at a point South  $4^{\circ} 30'$  West 726.7 feet from the northeast corner of said tract; containing 0.45 of an acre, more or less.

PARCEL NO. 15 (TRACT NO. 35)

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning at a point in the property line now or formerly common to Jeff L. Batson and Mrs. Kathleen B. Garrison South  $4^{\circ} 30'$  West 726.7 feet from the northwest corner now or formerly of Jeff L. Batson tract; thence South  $77^{\circ} 10'$  East 368.1 feet to a point on the property line now or formerly common to Jeff L. Batson and Mary B. McWhite South  $4^{\circ} 30'$  West 725 feet from the northeast corner now or formerly of the Jeff L. Batson tract; containing 0.59 of an acre, more or less.

PARCEL NO. 16 (TRACT NO. 34)

A 70 foot strip of land extended 35 feet on each side of and
