Thirty-Five Hundred Fifty-Seven and 50/100 DOLLARS, in the State aforesaid,

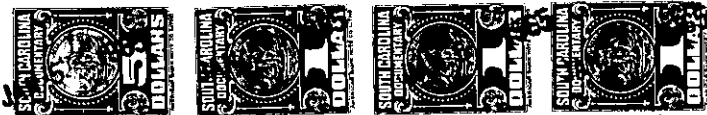
