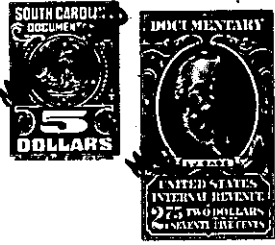
KNOW ALL MEN BY THESE PRESENTS, that I, John S. Ashmore
