to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) William Rollins and Irene B. Rollins and their heirs and assigns forever:

All that certain parcel or lot of land containing 2 acres, more or less, situated on the south side of Groce Meadow Road (State Highway No. S-92), leading from Greer to Mountain Veiw, about two miles eastward from Sandy Flat, Oneal Township, Greenville County, South Carolina, and being shown on a plat of the property of Paul F. Barbare, et al., by John A. Simmons, Registered Surveyor, dated April 5, 1965, and having the following courses and distances, to-wit:
