KNOW ALL MEN BY THESE PRESENTS, that G. P. Peterson

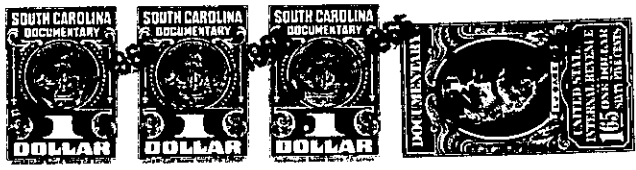
in consideration of One Thousand Two Hundred and No/100 (\$1,200.00) Dollars,
