It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all restrictions and limitations, Rules and Regulations of Graceland Cemetery now in force or which may hereafter be passed, relating to said Cemetery and the burial of the dead therein. This being the same property conveyed to the grantor by GRACELAND CEMETERY DEVELOPMENT CO., INC. by deed dated June 4, 1948 and recorded in the R.M.C. Office for Greenville County in Vol. 349 Page 179.
