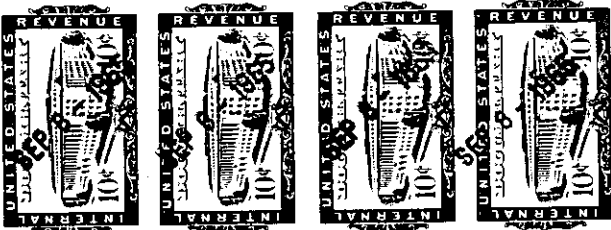
KNOW ALL MEN BY THESE PRESENTS, that I, L. M. Brown,
