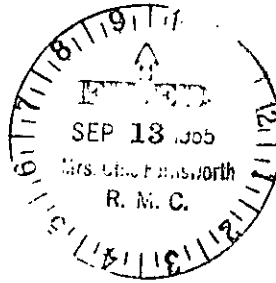

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Anita G. Hutchins (As sole Owner) and her heirs,

All that piece, parcel or Lot Land situate, lying and being on the Eastern side of Virginia Avenue near the City of Greenville, County of Greenville, State of South Carolina, Being known and designated as Lot No. 29, as shown on a plat of Highland Subdivision prepared by W. D. Neves, Surveyor, dated April 15, 1914, recorded in the RMC Offices for Greenville County, South Carolina, in Plat Book C and at page 146, having according to said Plat the following Metes and bounds:

BEGINNING at an iron pin on the Eastern side of Virginia Avenue at the joint front corner of Lots Nos. 28 and 29, and running thence with the line of Lot No. 28 N. 74-30 E. 130 feet to an iron pin in the line of property now or formerly of J. R. West; thence with the line of the said West property N. 15-10 W. 50 feet to an iron pin at the joint rear corner of Lots Nos. 29 and 57; thence with the line of Lot no 57 S 74-30 W. 130 feet to an iron pin on the Eastern side of Virginia Avenue; thence with the Eastern side of Virginia Avenue S 15-10 E. 50 feet to the point of beginning.
