unto JACK H. SPARMAN and SYBIL F. SPARMAN, their heirs and assigns forever:

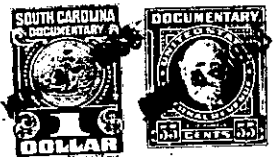
