ALL that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known as Lot No. 1 and a portion of Lot No. 2 on plat of property of Ralph McIntosh, which plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book SS, Page 64, and having according to a more recent plat entitled "Property of J. Ray Berryhill" made by R. K. Campbell, November 1, 1965, recorded in the RMC Office for Greenville County, S. C., in Plat Book LLL, Page 59, the following metes and bounds, to wit:
