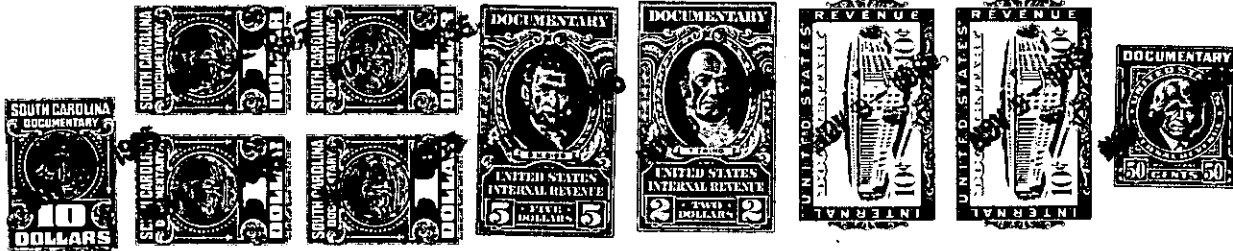
KNOW ALL MEN BY THESE PRESENTS, that Carolina Rentals, Inc.
