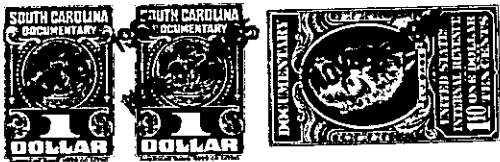
KNOW ALL MEN BY THESE PRESENTS, that J. MACK WOODS AND W. R. WOODS
