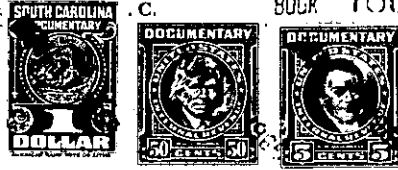

KNOW ALL MEN BY THESE PRESENTS, that we, Jerry D. Adams and Gloria S. Adams

in consideration of Four Hundred Fifty and no/100 . . . . . (\$450.00) . . . . . Dollars,  
and assumption of mortgage hereinafter mentioned  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Samuel M. Youngblood, and Linda S. Youngblood, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and known and designated as Lot No. 24, part of Avon Park, according to plat by C. C. Jones, dated December 1956, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 71, and having, according to said plat, the following metes and bounds; to-wit:

BEGINNING at an iron pin on the eastern side of Avon Drive, joint front corner of Lots 24 and 25, and running thence with the joint line of said lots, S. 84-18 E. 175 feet to an iron pin in the line of Lot No. 42; thence with the line of Lot No. 42 and continuing with the line of Lot No. 43, N. 5-42 E. 80 feet to an iron pin, joint rear corner of Lots Nos. 23 and 24; thence with the joint line of said lots, N. 84-18 W. 175 feet to an iron pin on the eastern side of Avon Drive; thence with Avon Drive, S. 5-42 W. 80 feet to the beginning corner; being the same conveyed to us by O. B. Godfrey by his deed dated August 30, 1965.

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage in the original sum of \$14,400.00 executed by the grantors to the First Federal Savings and Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1006, at Page 257, and having a balance due in the sum of \$14,379.78 as of this date.
