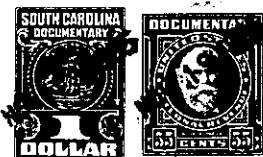

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 80 as shown on a plat of Marion Grove subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 137, and having according to said plat the following descriptions, to-wit:
