All my right, title and undivided interest in and to a piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Southern side of Grove Street, in the City of Greenville, being shown as Lots Nos. 16 and 29 on plat of the H. H. Harris land made by W. A. Hudson, March 21, 1908, recorded in Plat Book A at page 225, and described as follows, and having, according to said plat, the following metes and bounds:

BEGINNING at a stake on the Southern side of Grove Street 50 feet East from Judson Street, corner of Lot No. 15 and running thence with the line of Lots 15 and 28 due South 200 feet to a stake on the Northern side of Spring Street; thence with the Northern side of Spring Street S. 86-00 E. 50 feet to a stake, corner of Lot No. 30; thence with the line of Lots 30 and 17 due North 200 feet to a stake on Grove Street; thence with the Southern side of Grove Street N. 86-00 W. 50 feet to the beginning corner.
