All that piece, parcel or lot of land in Bates Township, Greenville County State of South Carolina, being shown as 25.47 acres on a plat of Property of the E. L. Benson Estate, prepared by Terry T. Dill, Surveyor, dated October 1965, and having according to said plat the following metes and bounds:
