**POWER OF ATTORNEY
AND REVOCATION OF PRIOR POWER OF ATTORNEY**

KNOW ALL MEN BY THESE PRESENTS: that the undersigned Corporation hereby;

(1.) Constitutes and Appoints as its true and lawful Attorney in Fact,
J. M. Guth of Greenville County, South Carolina

for it and in its name and stead to demand, reduce to possession, collect, receive, cancel, release, satisfy, discharge, or subordinate in whole or in part, any and all notes, collateral, judgments, decrees, mortgages, or liens of any nature on personal or real property, located, entered, filed for record, or recorded in any city or county in the United States and now or hereafter belonging to it, and in connection therewith to perform all acts, including the execution, acknowledgment, recording, and delivery of acquittances, releases, satisfactions, subordination agreements, and other instruments in writing, which may be necessary or desirable in exercising such powers, and including the execution of instruments authorizing, empowering, or directing any public officer as its Attorney in Fact to cancel, release, satisfy, and discharge of record any such judgment, decree, mortgage, or lien, hereby ratifying and confirming all acts and things done by virtue hereof; provided that these presents are subject to the power of said Corporation, hereby expressly reserved, to revoke the same at any time.

(2.) Revokes that certain Power of Attorney dated June 25 1962, and recorded in the office of the R. M. C. of said county in Book 702 Vol page 406

appointing J. E. Miano as Attorney in Fact for the undersigned with powers similar to those set forth above and hereby wholly withdraws said appointment and all powers conferred thereby.
