BEGINNING at an iron pin on the western side of the Miller Road, which pin is N. 6-45 E. 206 feet from an iron pin in the intersection of the Miller and Berry Roads, and running thence S. 87-45 W. 173.4 feet to an iron pin; thence N. 2-15 W. 125 feet to an iron pin; thence N. 87-45 E. 173.4 feet to an iron pin on the western side of Miller Road; thence with said Miller Road, S. 2-15 E. 125 feet to the beginning corner, containing one-half acre, more or less.
