KNOW ALL MEN BY THESE PRESENTS, that I, Clarence M. Buchanan

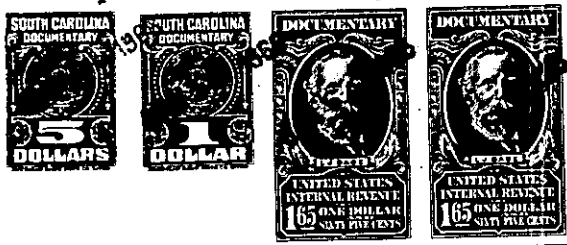
in consideration of Twenty-Five hundred Fifty and No/100-----(\$2550.00)-----Dollars,
