ALL those certain pieces, parcels or lots of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 28 and the northern half of Lot No. 27 as shown on plat of subdivision known as PARKDALE according to survey thereof made by Dalton & Neves, Engineers, in July, 1960, and recorded in the RMC Office for Greenville County in Plat Book RR, Page 55, and having, according to said plat, the following metes and bounds, to wit:
