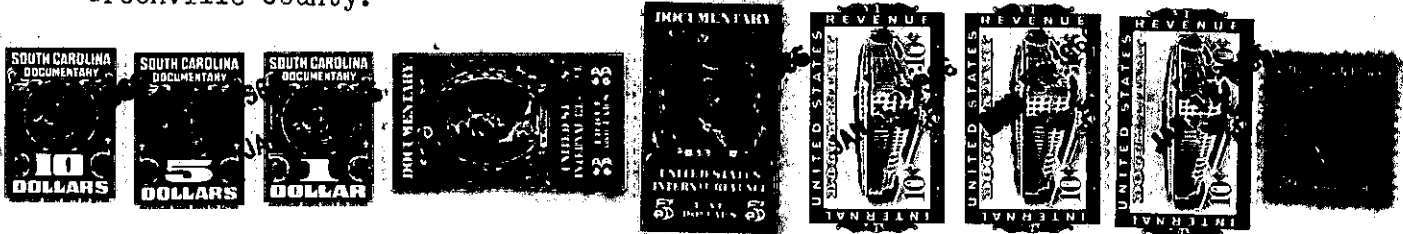
That I, William Alton Wooten,
