to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

GLENN E. ROGERS, HIS HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the easterly side of Balfer Drive, being shown and designated as Lot No. 97, on plat of Wade Hampton Gardens, Section III, according to plat recorded in the RMC Office for Greenville County, S.
