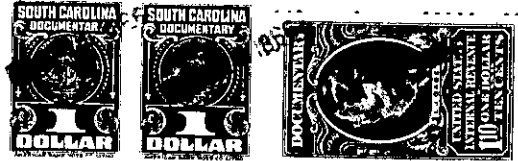

KNOW ALL MEN BY THESE PRESENTS, that I, J. O. SHAVER

in consideration of SEVEN HUNDRED AND No/100ths (\$700.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto DAVID WYNN, his heirs and assigns forever:

All of that lot of land situate on the South side of Knollview Drive, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 85 on plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the R.M.C. Office for Greenville County, S.C. in plat book KK at page 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Knollview Drive, at joint front corner of Lots 84 and 85, and running thence with the line of Lot 84, S 3-11 E, 230 feet to an iron pin; thence N 86-49 E, 100 feet to an iron pin; thence with the line of Lot 86, N 3-11 W, 230 feet to an iron pin on the South side of Knollview Drive; thence with Knollview Drive, S 86-49 W, 100 feet to the point of beginning. This being the same property conveyed to me by deed of Wrenn M. Creel recorded in the R.M.C. Office for Greenville County in Deed book 647 at page 8.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
