Holland and Betty H. Holland, their Heirs and Assigns, forever:

ALL that lot of land with the improvements thereon situate on the Northwest side of Choice Hill Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 2 on plat of property of R. G. Pace, recorded in the RMC Office for Greenville County, S.C., in Plat Book DD, Page 175, and having according to said plat, the following metes and bounds, to-wit:
