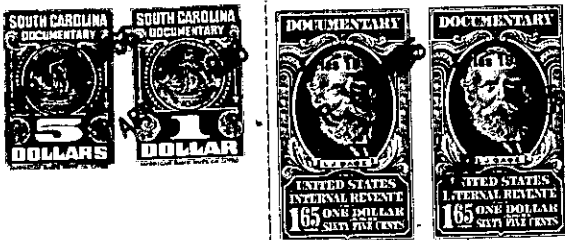
KNOW ALL MEN BY THESE PRESENTS, that I, WILLIAM M. EDWARDS,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto ALVIN TRAMMELL, his Heirs and Assigns, forever:

ALL that piece, parcel or lot of land located, situated and being on the west side of Randy Drive in the County of Greenville, State of South Carolina, known as Lot No. 31 in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat of Dalton & Neves dated March, 1957, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book RR, Page 20 (Revised April 6, 1964, and recorded in Plat Book RR, Page 20) and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of Randy Drive at the joint front corner of Lots Nos. 30 and 31 and runs thence along the line of Lot No. 30, S. 67-28 W. 200 feet to an iron pin; thence running N. 22-32 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 32; thence running N. 67-28 E. 200 feet to an iron pin on the west side of Randy Drive; thence running along the west side of Randy Drive, S. 22-32 E. 100 feet to the point of beginning.

THIS conveyance is made subject to the restrictions filed in the RMC Office for Greenville County, South Carolina, in Deed Book 643, Page 291, said restrictions amended and recorded in Deed Book 729, Page 91.
