DEED OF GRANT



KNOW ALL MEN BY THESE PRESENTS, that J. ODELL SHAVER

in consideration of Sixteen Thousand Five Hundred and no/100 (\$16,500.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

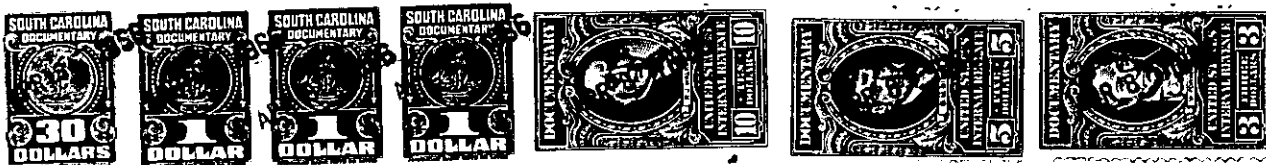
unto Billy L. Wright, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the Town of Mauldin, and being known and designated as Lot Number 21 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book BBB at Page 15, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Bartlett Street at the joint front corner of Lots 21 and 22 and running thence with the Northeastern side of Bartlett Street S 47-51 E 70.1 feet to a point; thence following the curvature of the Northern side of Bartlett Street S 68-24 E 48.25 to a feet; thence continuing to follow the curvature of the Northern side of Bartlett Street N 49-51 E 116.6 feet to a point at the rear corner of Lot 21; thence N 47-51 W 153.7 feet to a point at the joint rear corner of Lots 21 and 22; thence S 42-09 W 175 feet to a point on the Northeastern side of Bartlett Street at the point of BEGINNING.
