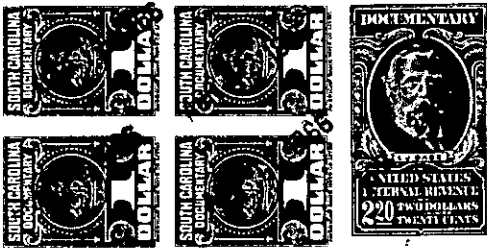
KNOW ALL MEN BY THESE PRESENTS, that I, R. L. CHILDRESS
