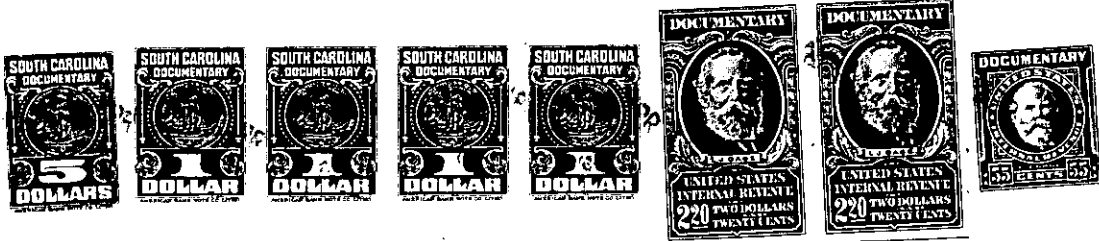

ALL waterlines, mains, valves, sleeves, hydrants, and appurtenances installed and located, in, under or along Collingwood Lane, Greenway Court, Archwood Court and Brushy Creek Road, in Greenville County, South Carolina, being 1076' of 6" C. I. Pipe, 799' of 2" Galv. Pipe, 2 - 6" valves, 1 fire hydrant, 1 6" x 6" Tapping sleeve and 1 - 6" Tapping Sleeve, and 6 - 2" valves, all as shown on drawing entitled "Eugene Rackley to City of Greenville", attached hereto and made a part of this conveyance.
